1) Call to Order: Chairman Randy McFarland.

2) Welcome to Commissioners and visitors: Chairman McFarland.

- 6) California History & Genealogy Room: Bill Secrest Jr. brought files donated by Ephraim Smith recently retired from Fresno State History department faculty. - ii) Suggestions for other applications: Chairman McFarland suggested that we start working on more applications. Commissioner Catallo spoke of things that will be coming up for Centennial years in Clovis. . Commissioner Laval brought up ranches in Clovis in area. Commissioner Enloe spoke of joining with Commissioner Pappas and Bill Secrest Jr. to fill out application on Masonic buildings.
- c) Centennial Farms: None.
- d) <u>Centennial Businesses</u>: Chairman McFarland has spoke with employee of Clevengers in Caruthers.
- e) Centennial Communities: Commissioner Pappas talked about Big Creek coming up in 2011. There will be five communities in 2012, Burrel, Huntington Lake, Biola, Mercy Hot Springs, and Lanare. Questioned about going to the Board. Place Big Creek on list. Motion to recommend Big Creek for inclusion to list of Centennial Communities motion by Commissioner Barile and second by Commissioner Pappas. Commissioner Shantz questioned what date we are working with. Chairman McFarland said that working with the earliest date of establishment.

## f) Centennial Schools:

- On March 15, 2011 the Board accepted the Centennial Schools application for Centennial Schools Register. It went to a consent item. Commissioner Pappas spoke of meeting with Supervisor Larry Powell along with Laurel Prysiazny. Commissioner Olson will have the two applications Sierra Elementary, and Auberry Elementary. Commissioner Shantz will meet with Commissioner Pappas to go over lists of schools.
- g) Threatened buildings in the City of Fresno: Commissioner Taylor announcement in paper Buddas church selling off the Temple in China Town. Commissioner Raven spoke of Fresno County Historical S ociety maybe being of some help in finding our more about it. Commissioner Taylor, JC Penney, B of A, and Bank of Fresno all threatened. High Speed Rail will use existing right of way but will be a conflict of running into Roeding Park
